It is our hope that an outspoken debate will develop in which members of the audience will be asked to participate and that hard concrete thinking will be done about what ohange really means. We hope to devote the following morning session of Conference to continued discussion of this subject. We can no longer go on calling for change while shying away from the inevitable consequences to our own way of life. We would like you to come prepared to participate in seeking answers to the questions posed including thought on such things as (i) can the free enterprise system survive change to majority rule? $\quad$ ii) Do we understahd that the black demand is for majority rule ? Is it inevitable and do we understand the implications? (iii) Can a reconstruction. Government hope to command sufficient loyalty in the general population to maintain law and order iv) Is a socialist or a capitalist system more likely to lead to future stability and development in South Africa? $\quad v$ ) Is this the choice or can we hope for new political thinking? vi) If so, what?
