Please remember the Transvaal Regional Conference on February 14th at 9.30 a.m at 8 Cowie Road, Forest Town.

We are going to discuss major issues and the Transvaal Region's reaction to issues brought forward by other Regions. So far Natal Coastal has sent up four resolutions dealing with 1. Restriction of the Voice of dissent and protest in South Africa, 2. Family Life and this encompasses Squatters and hostels. 3 Trade Unionism, 4. Detention without trial and the attitude of those in charge.

Other major issues are "The New Constitution in South Africa, and this will affect us all - Black Education, Economics and a new Charter for Women

Cape Town has suggested that we amend the original Charter drawn up by the Sach several years ago. A small sub-committee in the Transvaal has suggested a simplified charter which we detail below

- L. EVERY WOMAN HAS THE RIGHT TO FULL ADULT LEGAL STATUS ON THE ATTAINMENT OF HER MAJORITY OR IN MARRIAGE.
- 2. EVERY WOMAN HAS THE RIGHT TO FREEDOM OF MOVEMENT AND DOMICILE.
- 3. EVERY WOMAN HAS THE RIGHT TO OWN OR TO RENT PROPERTY IN HER OWN NAME.
- 4. EVERY WOMAN HAS THE RIGHT TO SEE EMPLOYMENT ON AN EQUAL BASIS WITH MEN;
 TO BE PAID THE RATE FOR THE JOB.
 TO FAIR STANDARDS AND CONDITIONS OF WORK.
- 5. EVERY WOMAN HAS THE RIGHT TO LIVE WITH HER HUSBAND WHERE HE LIVES AND WORKS
- 6. EVERY WOMAN HAS THE RIGHT TO CHOOSE WHETHER OR NOT SHE WILL BEAR CHILDREN
- 7. EVERY WOMAN WHO IS A MOTHER HAS THE RIGHT TO LIVE WITH, PROTECT AND CARE FOR HER CHILDREN.

Transvaal will also be submitting papers on Workmen's Compensation, Squatters and Winterveldt, Police and Political Trials, Leasehold Rights and Citizenship

and will contribute to the discussion on the Year of the Child.
