Dear Everyone,

National Conference: Legal advice regarding the possible amendment of our Constitution to extend our membership to ex-South African citizens is that there are good grounds for leaving the Constitution as it is. If you are agreeable we shall let the matter rest there.

Transvaal Region is anxious to know as soon as possible what accommodation will be required by delegates to Conference. I realise that you have not yet elected your delegates, but please bear in mind that hotel accommodation is at a premium and if you will be requiring it in preference to private accommodation the sooner we know about it the better.

Please let me know whether you are satisfied with the suggested list of speakers for the opening night, so that I can issue an invitation.

FACT PAPERS. At its Regional Conference Transvaal Region decided to present fact papers on a comparison of issues covered in Post and the English Press; a comparison between promises of change and what has actually happened; rural poverty; a Bill of Rights; Nel's Dairies; and background information on the dole.

ITEM FOR DISCUSSION. Security Legislation and bannings of organisations and individuals.

Commission on Security Legislation: As I have had no comment from Regions our Memorandum will be presented to the Commission after it has been vetted by a Sub-Committee.

Constitution Campaign: Inkatha chose to make public its withdrawal from our informal group because of its anger with a member who had insulted Chief Buthelezi. I am presently trying to mend the rift, but it won't be easy.

Removals: I wrote to Dr. Koornhof about the enforced removals from the Batlokwa area near Pietersburg to the effect that words which contradict deeds are counterproductive and that the people should be permitted to remain where they are and wish to be. We are presently investigating possible ways of supporting the two further chiefs whose people are threatened with removal, but there doesn't seem to be any way of preventing the Government from doing what it sets out to do. However, we must try:

Prime Minister: I decided to withhold the letter to the Prime Minister (Circular 12/1979), because there were strong differences of opinion within Sash, and although I personally regarded it as a tactic and certainly not an infringement of principle I did not feel sufficiently strongly about it to perservere.
