COLOURED MANAGEMENT COMMITTEE.

There is furious anger over the way the City Council ignored the detentions of Mylie Richards and Mohammed Danghor, making no effort to contact their families or make any enquiries or representations on their behalf. We share this The City Council even refused to allow Janet Levine's request that because Messrs. Richards and Danghor were colleagues and elected public representatives their detentions should be debated as a matter of urgent public interest. The Management Committee refused to intercede for them on the grounds that the education boycott did not fall within the scope of the City Council.

LAWYERS FOR HUMAN RICHTS.

A large turn out of members heard Johann Kriegler S.C., explain the objects of the Lawyers for Human Rights Committee. Seldom have we been treated to such clarity and honesty. The committee is there to do an essentially professional job in an effort to improve the quality of legal thinking and proformance. will welcome suggestions and co-operation from the Black Sash. They intend to proceed soberly, slowly and moderately.
